The combination of these two technologies allows for any type of operation linked to a digital identity with full legal backing, in a completely immutable and transparent manner to third parties.

### What Q\_Id do you need?

#### **Q\_Id of individual person**

Identifies the subscriber as an individual person.

#### **Q\_Id of belonging to a company**

Identifies the holder as an individual person linked to a corporation.

#### **Q\_Id Qid corporate electronic seal**

Identifies the subscriber as a legal entity.

#### **Q\_Id of legal representative**

identifies the subscriber as a corporation (company, private or public entity) and the Signatory as its representative.

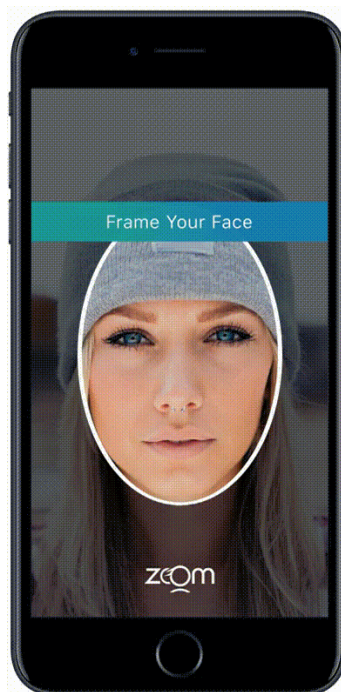
